RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT in consideration of the vendor/artisan area at the Fall Festival located at the property of William J. Gaither and Gloria L. Gaither located at 1617 South Park Ave., Alexandria, IN 46001 on September 22-23, 2017.

I hereby agree as follows:

1. To waive any and all claims that I have or may have in the future against William J. Gaither and Gloria L. Gaither, Gaither Family Resources, Gaither companies or the Fall Festival and their employees and volunteers (all of whom are hereinafter collectively referred to as "the Releasees") and to release the Releasees from any and all liability for any loss, damage, injury or expense that I may suffer as a result of or arising out of any aspect of my use of the vendor/artisan area due to any cause whatsoever, including negligence or theft; or in respect of the provision of or the failure to provide warnings, directions, instructions or guidance as to the use of the vendor/artisan area.
2. To hold harmless and indemnify the Releasees from any and all liability for any loss, damage, injury or expense to any third party, resulting from the use of the vendor/artisan area.
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, assigns, administrators, and representatives, in the event of my death or incapacity.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.

**RULES ON ENTRY**

1. All work must be suitable to a family-oriented show. We reserve the right to remove any exhibit not complying with these rules and regulations.
2. Booths are to be reserved in your name only. Exhibitors cannot sub-lease assigned booths; however, you may share a booth.
3. All exhibitors are expected to provide enough stock for the entire show, set up before show hours, and remain open until closing time. All exhibitors must remain set up until 3:00 p.m. on Saturday.
4. Set up may begin on Thursday from 3 pm – 7pm and should be complete, with vehicles off exhibit area by 10am on Friday and 10am on Saturday. No vehicles will be allowed in the exhibit areas between 10 – 6 on Friday and 10 – 3 on Saturday. Tear down is not allowed until after 3pm on Saturday.
5. Exhibitors will have the option of providing their own tent or utilize space in the vendor tent provided by Gaither Family Resources Fall Festival.
6. Single spaces are 10 x 10. Double spaces are 10 x 20. All spaces are located on relatively level ground.
7. There is NO access to electricity.
8. Minimal after-hours security will be provided with the understanding that Gaither Family Resources Fall Festival is not and will not be responsible in any way for loss or damage to participant's property. Exhibitors are responsible for their own personal and property liability.
9. Gaither Family Resource Fall Festival cannot be held liable or responsible for loss or damage to work or injury to any person participating in the show. The festival cannot be responsible for weather damage to products. A signed application constitutes a contract to follow all rules and regulations and is a commitment to participate personally if accepted.
10. There is no smoking or alcohol use permitted on or around the festival or concert properties.
11. State taxes should be collected by all vendors.
12. Clean up – each vendor is responsible for leaving their booth area as found. Any trash must be cleaned up and removed.
13. This festival is outdoors. We would like to always plan for great weather, however we cannot control the weather conditions.
14. All food vendors must comply with the Board of Health Guidelines applicable to their business. Be sure you have a current Board of Health Certificate in your possession prior to the event.
